**CERTIFIED CHECK, MONEY ORDER OR ATTORNEY CHECK ONLY**  
(All fees and mileage are payable in advance to the "Sheriff of Suffolk County")

<b>PROPERTY EXECUTION</b>	\$20 fee plus mileage; original & 6 copies.
<b>WITH BANK LEVY</b>	\$20 additional fee plus \$30 for each person plus mileage; 3 additional copies of the Execution, if natural person, 1 Exemption Notice & 2 Claim Forms.
<b>WITH 3<sup>rd</sup> PARTY LEVY</b>	\$20 additional fee; 3 additional copies of the Execution.
<b>WITH PROPERTY LEVY</b>	\$1200 estimated expenses for vehicle levy; \$200 estimated expenses for business levy.
<b>REAL PROPERTY</b>	\$20 fee plus mileage, \$1500 estimated expenses; original & 7 copies with Index #, attorney cover letter. Contact office for requirements.
<b>INCOME EXECUTION</b>	\$100.00 fee for 1 <sup>st</sup> and 2 <sup>nd</sup> stage service upon debtor and the employer (if necessary). Add an additional \$2 fee if the employer is a municipality; original & 7 copies.
<b>SERVICE OF SUMMONS, SUBPOENA OR OTHER PROCESS</b>	\$20 & 4 copies for <u>each</u> person requiring service plus mileage; for information Subpoena, 1 additional copy along with a self-addressed, stamped envelope.
<b>SERVICE OF NOTICE OF PETITION</b>	\$55 fee plus mileage, \$20 for each additional tenant; 4 copies.
<b>TOLL STATUTE ONLY</b>	\$20 per defendant; 3 copies per action; attorney letter of instruction; self-addressed, stamped envelope.
<b>EVICITION</b>	\$15 fee plus mileage; \$15 for 14-day notice for each defendant; \$75 to enforce warrant plus mileage; \$200 estimated expenses; original & 6 copies for 1 defendant, additional defendants (including John Does), 3 copies for each; landlord or attorney phone number. <b>LIST OF PROPERTY TO REMAIN ON PREMISES.</b>
<b>WARRANT OF ARREST</b>	\$55 fee plus mileage; original & 3 copies of: Order, Affirmation, Final Order, Affidavit of Service and completed Information Sheet.
<b>COMMITMENT ORDER</b>	\$55 fee plus mileage; \$10 commitment fee; 3 certified copies.
<b>ORDER OF SEIZURE</b>	\$120 fee plus mileage, additional \$50 if third party has property; \$20 for service of order on defendant or person in possession; \$20 for service of Summons and/or Complaint; original to be filed by attorney; 5 certified copies per service; undertaking; attorney affirmation; all supporting papers; Index #; cover letter.
<b>ORDER OF ATTACHMENT</b>	\$90 fee plus mileage; \$50 for levy & each additional levy plus mileage; \$20 for service of order on each defendant plus mileage; \$20 for service of Summons and/or Complaint per defendant; \$20 for filing description of property levied; original to be filed by attorney; 5 certified copies per service; undertaking; attorney affirmation; all supporting papers; Index #; cover letter.
<b>ORDER OF ATTACHMENT – REAL PROPERTY ONLY</b>	SEE ABOVE FOR FEES; check for \$220 payable to the Suffolk County Clerk, add \$200 fee for each additional parcel. Attorney submits the following: 5 certified copies of the Order (certified by attorney or court); undertaking; attorney affirmation; all supporting papers; Index #; cover letter; District, Section, Lot & Block #s on front page of Order. Add \$200 fee for each additional parcel.
<b>CONVEYANCE DEED</b>	\$30 fee; 2 original Deeds completed by attorney; certified copy of Order; cover letter.
<b>POUNDAGE</b>	5% of first \$250,000; and 3% upon the residue.
<b>ORDER &amp; JUDGMENT</b>	\$20 fee plus mileage; original execution & 6 copies; certified copy of Order; Sheriff's poundage in advance. Contact office.
<b>AFFIDAVIT OF POSTING</b>	\$20 per posting plus mileage.
